Session 1 (Day 1) WHS Awareness

LEARNING OUTCOMES

- Develop an understanding of PCBUs "Primary Duty of Care" and what they need to do to ensure compliance;

- Develop an understanding of the importance of consultation, coordination and cooperation and of the issue resolution process for your business; and
- Develop an understanding of the financial consequences for noncompliance.

Session 2 (Day 2) WHS Risk Management

- Explain the importance of a pro-active approach vs reactive to risk management;
- Explain the process for identifying hazards and incidents in the workplace to your supervisors;
- Describe the process of risk assessment;

- Identify workers, officers and PCBU responsibilities in relation to risk management, WHS consultation and hazard and incident reporting.

Session 3 (Day 3) WHS Committee Training
